

The Commission at its meeting held on 26.05.2023 has approved the recommendation of the Standing Committee on Autonomous Colleges to extend the autonomous status to **M. Kumarasamy College of Engineering, Thalavapalayam, Karur-639 113 affiliated to Anna University, Chennai** for a period of 10 years from the academic year 2022-2023 to 2031-2032 as per clause 8.2 of the UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations, 2023.

The University, is therefore, requested to issue necessary notification within 30 days regarding the Extension of autonomous status to the College as per UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations, 2023.

The college should apply to University Grants Commission for extension of autonomous status atleast three months before the completion of autonomy period.

This is regarding Compliance Report submitted by M. Kumarasamy College of Engineering, Thalavapalayam, Karur-639113, Tamil Nadu for the UG Computer Science & Engineering program which was accredited by NBA in Tier-I for academic years 2018-19 to 2020-21 whose validity of accreditation had expired on 30.06.2021. The program was granted accreditation for the Academic Year 2021-22 i.e. upto 30/06/2022 on account of present pandemic situation due to Corona Virus.

2. An Expert Team conducted data verification of the program on 30th April, 2022. The report submitted by the Expert Team was considered by the concerned Committees constituted for the purpose in NBA. 3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. The program has been granted accreditation for further 3 years. M. Kumarasamy College of Engineering, Thalavapalayam, Karur-639113, Tamil Nadu should submit fresh online application through eNBA portal at least five months before the expiry of validity of accreditation mentioned above.

5. The accreditation status awarded to the program as indicated in the above table does not imply that the accreditation has been granted to M. Kumarasamy College of Engineering, Thalavapalayam, Karur-639113, Tamil Nadu as a whole. **As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation.
